1. "One Connection = One House, One Kitchen" above mentioned connection charge is for One point of Kitchen. Which includes 15 meters GI pipe from isolation valve up to gas tap.
2. All piped work, fittings, meter and other materials used for the purpose of supply of PNG shall remain the property of the Supplier and the Customer shall remain the custodian of such properties.
3. GI pipe is used more than 15 meter from the isolation valve up to gas tap shall be payable (as non-refundable) by customer.
4. Bill shall be raised on bi-monthly, which will be payable by customer. If customer has opted instalment scheme, Instalment(s) will be charged in the gas bill and customer is liable to pay.
5. 0-4 burner traditional gas stove conversion has been included in the above connection charges, conversion charge for any other type of Non-conventional type of Gas stove, oven not included in the above mentioned connection charges, which shall be get through by customer.
6. Any other charges related to any alteration/modifications will be charges separately as per prevailing charges and this type of change will be done by the company only.
7. There may be fluctuations in Connection charges in accordance with Government's rules, tax, duty or timely change.
8. GEL reserves the rights to change any of the charges mentioned in this tariff card without any prior notice/intimation.
9. Connection will be provided subject to availability of gas pipeline in nearby area.
10. Billing will be start on the same day, when gas supplies started in the customer premise, subject to conditions.
11. Customer has to clear all pending due for gas consumption and balance connection charges before applying for Temporary disconnection.
12. This connection charge will be subject to terms and conditions of registration form.
13. Geyser Point(s) and Extra Kitchen Point(s) will be provided as per technical feasibility in the each connection.
14. The conversion of the gas burner will be changed only once.
15. Line dismantle charges at actual or as informed by GEL representative.
16. In EMI scheme, customer will be charged as 62 EMIs of Rs.80/- and one last EMI of Rs.40/-.
